1. Divisions are categorized by Midgets (2nd, 3rd, 4th, 5th or 6th grade), Juniors (7th, 8th or 9th grade) and Prep (9th, 10th, 11th or 12th grade). Newer teams (consisting of 2nd or 3rd grade) will be in the lowest Midget division and will play with the smaller ball as designated by JAO rules (unless both teams prefer to use the (larger) regulation ball). Brackets are limited to eight teams and will be accepted on a "first come first serve" basis. **NOTE: If a bracket is not filled, your team may be subject to be mixed with another bracket within your division.**
2. Team Rosters should be league rosters as submitted in JAO/SEYO/GEO or any other respective organized league. High school players should play with their respective "league" teams prior to playing on their high school team. Any roster additions must be noted and deemed acceptable by the Wanjettes Tournament Committee. **FINAL ROSTER DEADLINE: MARCH 12, 2005**
3. Teams or players may participate in a higher bracket (if desired), however players participating in the SCWAU (or equivalent Women's League) will not be allowed to play in this tournament.
4. Each team is responsible for their insurance during the Wanjettes Tournament and will release the Wanjettes and associated participating school districts from liability for any injury sustained by a player, coach or family member. Waiver must be signed by the parents, coach and team representative (Parent Rep/Coach) and submit along with team roster.
5. Unsportsmanlike conduct by players, coaches, families and fans are strictly prohibited. Any such actions may cause a team to forfeit or suspend them from participation in future tournaments.
